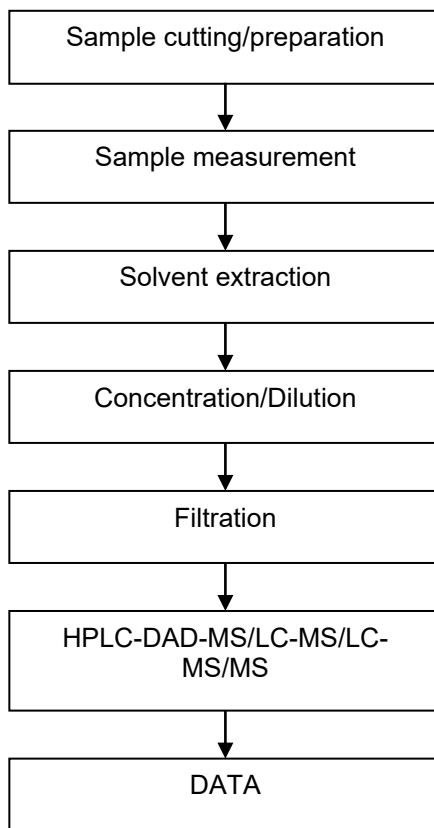

Bisphenols Testing Flow Chart



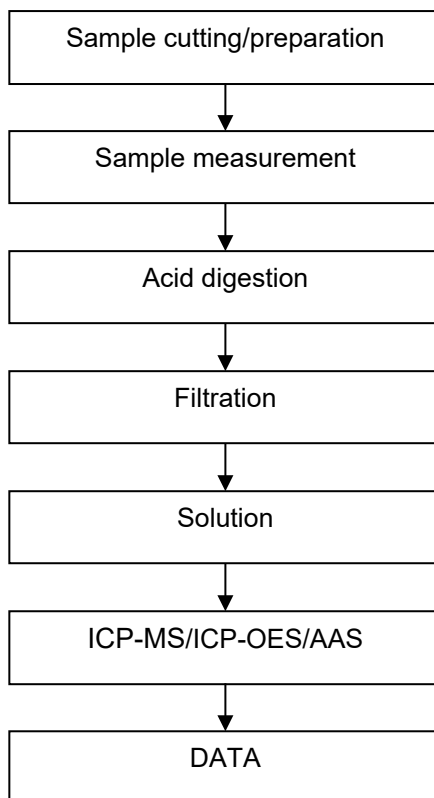

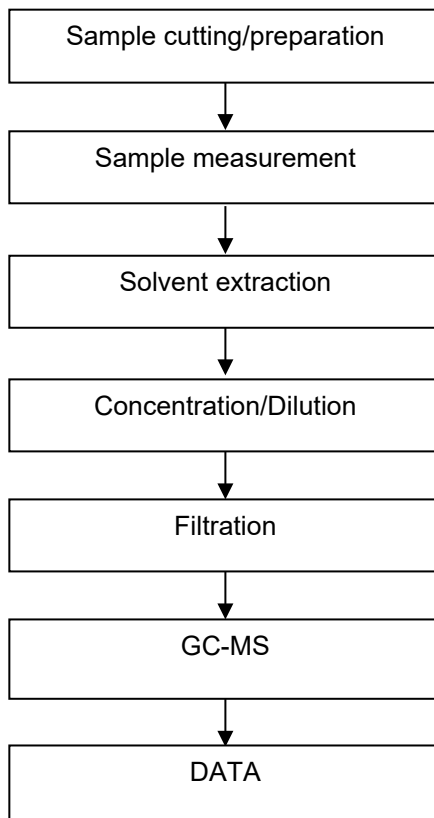
